

## **Memorandum of Understanding**

between

**Physiopedia Plus Ltd**

and

**Ivano-Frankivsk National Medical University**

This Memorandum of Understanding (MoU) is established by

PHYSIOPIEDIA PLUS LTD hereafter referred to as "Physiopedia", a company incorporated and registered in England and Wales with company number 07878211 whose registered office is at 10 Queen Street Place, London, EC4R 1BE, United Kingdom, and represented by Rachael Lowe, Chief Executive Officer.

And

Ivano-Frankivsk National Medical University, hereinafter referred to as IFNMU, a higher educational institution incorporated and registered in Ukraine whose registered office is at 2 Halytska Street, Ivano-Frankivsk, Ukraine and represented by Prof. Mykola Rozhko, Rector

Both organizations are hereinafter referred to as "Parties" collectively or "Party" individually.

## **Purpose**

*Whereas* the Parties manifest their support to the WHO Call for Action: Rehabilitation 2030,

*Whereas* the Parties recognize the importance of collaboration and believe that expansion and development of the cooperation between the two organisations will contribute to strengthening the rehabilitation workforce and consequently to improve access to rehabilitation services,

*Whereas* the Parties acknowledge that cooperation aiming at educating rehabilitation professionals will bring mutual benefits towards the accomplishment of the mission of both Parties,

*Therefore*, the Parties to this Memorandum of Understanding agree on the following:

## **Article 1**

The Parties will support cooperation in areas of joint interests on the basis of mutual benefits, in accordance with the provisions of this Memorandum of Understanding.

This collaboration may include exploring future joint or cooperative programmes and projects of mutual benefit.

## **Article 2**

Physiopedia will commit to:

- a) Granting free access to Physioplus to the organisations' community of members/staff/students over the period 2022-2025

## **Article 3**

IFNMU will commit to:

- a) Providing free access to Physioplus to its community of members/staff/students and shall not at any time sell on these services.
- b) Encouraging engagement by promoting Physioplus and the online courses to its community of members/staff/students.
- c) Providing data collected in relation to the use of the Physioplus platform by its community of members/staff/students and feedback, insights and information via online surveys on request by Physiopedia.
- d) Share existing documents of relevance for the development of education and training resources.
- e) Permit Physiopedia to use data shared for research and publication purposes.
- f) Ensure that in receiving and making use of Physioplus it shall at all times comply with and ensure its members comply with the most recent website Terms of Service and Privacy Policy, as may be amended from time to time at Physiopedia's absolute discretion.

#### Article 4

The Parties shall consult with each other before any confidential information is shared with any third party or disclosed for commercial purposes.

#### Article 5

The Parties, respectively, will appoint a liaison person that carries the main responsibility for the contact between the organizations, and acts as respective representative at joint meetings.

#### Article 6

This Memorandum of Understanding is at-will and may be modified by mutual consent of authorized representatives of the Parties.


It shall become effective upon signature by the authorized representatives of the Parties and will remain in force until 24 September 2025, unless terminated earlier by either Party upon thirty (30) days, by written notice to the other Party.

At the end of the validity period the agreement is subject to review, and shall be extended, modified or terminated by mutual consent of the Parties.

This Memorandum of Understanding is a non-exclusive partnership, which does not restrict either party from establishing agreements with other entities.

*In witness whereof*, the undersigned, duly representing the two Parties concerned, have signed the present Memorandum of Understanding in English language.

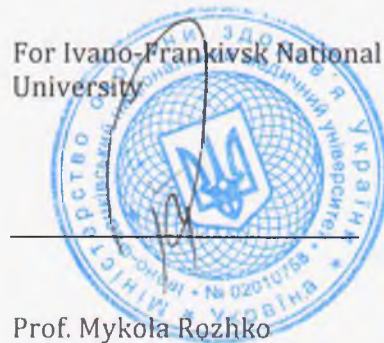
